The Government of the Socialist Republic of Vietnam (GoV) has received a credit from the Ministry of Foreign Affairs and International Cooperation - Directorate General for Development Cooperation (MAECI/DGCS) of the Government of the Italian Republic in the amount of EURO12.697.606,00 toward the cost of the project "Improving the capacity on training, scientific research and healthcare at Hue University of Medicine and Pharmacy and Hue University Hospital" belonging to the program "Improvements of health services in selected provinces of Central Vietnam and at Hue University of Medicine and Pharmacy". GoV intends to apply part of the proceeds of this credit, to a maximum amount of EURO 450.000,00, to payments for consultancy services required for the project implementation and to be of at least 80% of Italian origin.

- 2. The Call for Tender is divided into two lots:
 - Lot 1 Architectural planning, design and supervision Maximum amount EURO 100.000,00
 - Lot 2 Training activities
 Maximum amount EURO 350.000,00

The duties of the consultants shall include:

For the architectural planning: revise the existing master-plan and feasibility studies, provide the adequate technical support for the design of a new 7 floor hospital building, the preparation of tender documents and a preliminary design of the Infection Control Unit, provide technical assistance supervision, drawing up annual work progress reports for the Coordination Project Management Unit (CPMU) and the Donor, during the period of construction activities.

For the training activities: identify and develop the training modules to be supported in the field of biomedicine, manage the study grants for Vietnamese pupilsand organize training modules in Vietnam, during a two-year period. Provide distance learning courses and procurement of e-learning, multimedia conference room and bioinformatics lab hardware and software required for the courses execution.

The consultants, together with the Hue University of Medicine and Pharmacy (HueUMP) Project Management Unit (PMU), will be responsible for the general project administration and management, including the budget monitoring, related to the Contract funds out of which payments and services are made.



 The consultant may submit a tender for one or all of the lots. A separate application is required for each lot if tendering for all lots. The contract will be awarded on the lot basis.

Selection of consultants follows the Quality and Cost Selection Method (QCBS) and procedures described in the documents of Request for Proposal of Service (RFP), in accordance with policies that is suitable for the Decree N. 63/2014/ND-CP dated 26 June 2014, of the Socialist Republic of Vietnam, amended according to the eligibly and ethic clauses for contracts financed through funds provided by MAECI/DGCS.

The awarded entity shall reimburse to the Italian Agency for Development Cooperation the costs of publication of the bid notice on the Gazzetta Ufficiale della Repubblica Italiana, pursuant to art. 66 par. 7bis of D.lgs 163/2006. Where awarded entities are more than one (one for each lot), costs will be allocated in proportion to the awarded contract value. The terms of reimbursement will be detailed in the contract.
